CALL TO ORDER AND APPROVAL OF MINUTES

DISCUSSION, MIKE LOWE, SCOTT ST., C-1, CENTRAL BUSINESS DISTRICT

Mike Lowe was present to discuss subdividing the two buildings he owns which are on one lot, into two. The lot line would be along the common interior wall, and he would dedicate the road to the city. He stated he was requesting variances for lot width and setbacks, and he said he had a plat, but was not submitted.

There was discussion of the proposed plan of services. Mayor Parker reported on accessibility of water and new water tank with money from the County in April. The road Vicon builds will be part of the development, not a city road. A plan of services will need to be generated by the city and forwarded to the planning commission for a report.
