# CALL TO ORDER AND APPROVAL OF MINUTES

Chair, Mike Atkins called the meeting to order at 6:00 p.m. The minutes from the December 9, 2024, meeting were unanimously approved on a motion by Chad Johnson seconded by Cynthia McDaniel.

### **ELECTION OF OFFICERS**

Although not on the agenda, it was time for the election of officers. Mr. Johnson moved to add the item to the agenda which was seconded by Ms. McDaniel and approved unanimously. Ms. McDaniel moved to elect Mr. Johnson for another term as secretary. The motion was seconded by Mr. Atkins and approved unanimously. Ms. McDaniel moved to elect Mike Atkins for another term as chair which was seconded by Mr. Johnson and approved unanimously.

# ZONING ORDINANCE AMENDMENT, SECTION 7.080, AMENDMENTS TO THE ORDINANCE AND SECTION 7.110, REMEDIES

The ordinance to amend Section 7.115, Remedies to add penalties for violations was recommended for approval by Mr. Johnson and seconded by Ms. McDaniel and approved unanimously.

The ordinance to amend Section 7.080. Amendments to the Ordinance, to amend public hearing notice from 15 days to 21 days, was recommended for approval by Mr. Johnson and seconded by Ms. McDaniel and approved unanimously.

The ordinance to amend Section 7.030. Zoning Compliance Permit, to amend Application for a Site Permit to be submitted 14 days prior to the meeting at which it will be presented was recommended for approval by Mr. Johnson and seconded by Ms. McDaniel and approved unanimously. Staff will forward ordinance amendments to the city so that they can be forwarded to city council for approval.

#### OTHER

There was a discussion about property owner who owns a vacant lot and wants to move a mobile home onto the property. The mobile home was in line with her price range. The property was determined to be in the R-1 Low Density Residential District which does not permit mobile homes. There was a discussion of permitted uses in the R-1 and R-2 which only permits mobile homes in a mobile home park. Existing non-conforming buildings are allowed.
